

# Legislation

### Some products exempted from official controls at border checkpoints

Commission Delegated Regulation (EU) 2019/2122 sets out rules on the cases in which and conditions under which certain categories of animals and goods forming part of passengers' personal luggage are exempt from official controls at border checkpoints. As certain low-risk, shelf-stable composite products not containing meat are exempt from official controls at border checkpoints, the lists of exempted composite products in both delegated regulations need to be adapted.
