In 2021 the Direction générale de la concurrence, de la consommation et de la répression des fraudes (DGCCRF) carried out a control plan targeting olive oil. 39% of the 211 establishments checked and more than 80% of the 130 products analysed presented anomalies. Non-compliances related to the presence of other vegetable oils, quality standards, origin labelling and pesticides found in organic products.
